By providing an appropriate environment including shelter and a comfortable resting area.
-  **Freedom from Pain, Injury and Disease**
By prevention through rapid diagnosis and treatment.
-  **Freedom to Express Normal Behaviour**
By providing sufficient space, proper facilities, and the company of the animal's own kind.
-  **Freedom from Fear and Distress**
By ensuring conditions and treatment which avoid mental suffering.

RSPCA Tasmania operates three Animal Care Centres, a veterinary clinic at Mornington, a State-wide animal cruelty Inspectorate, a pet supply store at each centre and behavioural advice.
